## Life Membership Nomination Proforma

*Please note: Montrose Football Club rules relating to Life Membership are as follows*

- 45.1 Life Membership shall be awarded automatically to players who have played 175 senior games and may also be awarded to those members who have contributed significantly in accordance with the published criteria of the Board of Management.
- 45.2 Members who are non playing members shall be nominated and seconded by two (2) other members of the club, such nomination being submitted to the Board of Management.
- 45.3 Members who are non playing members shall be recommended by the Board of Management to the members at the Annual General Meeting who shall vote on such recommendation.
- 45.4 Life Membership shall be accepted when members at an Annual General Meeting where 75% members present vote in favour of the Board of Management recommendations being accepted.
- 45.5 A Life Member shall be able to attend any General or Special General Meeting and shall have full voting rights.
- 45.6 A Life Member shall not pay any membership fees from the acceptance at the Annual General Meeting of his or her recommendations to that meeting.
- 45.7 The criteria for Life Membership may be amended and changed from time to time on the recommendation of the Board of Management and such recommendation being passed by 75% present at the Annual General Meeting.

# BOARD OF MANAGEMENT CRITERIA FOR LIFE MEMBERSHIP

The Board of Management in considering any nomination by two (2) members of another for Life Membership may have two Life Members give their deliberation in relation to such nomination and make recommendations to the Board of Management taking into account the following:

1. The Board of Management shall not nominate (the nominee) more than two (2) non playing members in any one year to the members at the Annual General Meeting.
2. The nominee shall have served a minimum as specified below and contributed significantly to the aims and objective of the club giving outstanding service to the club for:
  - a) President, Secretary and Treasurer five (5) years service;
  - b) Other persons on the Board of Management eight (8) years service;
  - c) Other persons on committees ten (10) years service; and
  - d) Other persons giving outstanding service to the club for twelve (12) years of more.
3. The nominee shall be nominated in writing on a Form approved by the Board of Management from time to time and supported by written submissions from two referees as to the suitability of the nominee.
4. The Board of Management may interview the nominator, seconder and referees as to the suitability of the nominees either with or without two other Life Members present as the Board of Management may in its absolute discretion decide.
5. Any application which is not successful in obtaining recommendation to proceed to an Annual General Meeting shall be treated by the Board of Management in the strictest of confidence.
6. Unsuccessful nominations may be resubmitted at a later date to the Board of Management for their consideration again.
